 - b. a director, trustee, officer, like official, manager or in control of a registered charity during a period in which the charity engaged in conduct that may reasonably be considered to have constituted a serious breach of the requirements for registration under the Income Tax Act and for which its registration was revoked within the last five (5) years, or
 - c. a promoter of a tax shelter that involved a gift to a registered charity the registration of which was revoked within five (5) years preceding the particular time for reasons that included or were related to participation in the tax shelter.
